ORDER:-

The Hon'ble Minister (Forests and Khadi) has made the following announcement among others on the floor of Assembly on 28.03.2025:-

"In order to mitigate human – wildlife conflict especially with elephants, Government has planned to install steel rope fence in Cauvery North Wildlife Sanctuary areas at a cost of Rs. 31.00 crore"

2. Adverting to above, the Principal Chief Conservator of Forests and Chief Wildlife Warden has requested to sanction Rs.32.33 Crore for erection of Steel wire rope fence along the Boundary of Cauvery North Wildlife Sanctuary to mitigate human, Elephant Conflict of Hosur Forest Division in Krishnagiri District.

3. The Government after careful examination of the proposal of the Principal Chief Conservator of Forests and Chief Wildlife Warden have decided to accord administrative sanction of Rs.31,00,00,000/- (Rupees Thirty one crore only) and financial sanction of Rs.20,00,00,000/- (Rupees Twenty Crore only) during the year 2025-2026 for erection of Steel wire rope fence along the Boundary of Cauvery North Wildlife Sanctuary to mitigate Human- Elephant Conflict of Hosur Forest Division in Krishnagiri District.

4. The expenditure sanctioned in para 3 above shall be debited into the following Head of Account:-
