# ORDER:

Under the circumstances stated by the Principal Chief Conservator of Forests in his letter second read above, the following amendment is issued to the Government Order first read above.

#### **AMENDMENT**

For the existing para 7 to 10 of the G.O.(Ms).No.101, Environment, Climate Change and Forests (FR.10) Department, dated 14.06.2022, the following shall be substituted:-

"7. The Government after careful examination have decided to accept the request of the Principal Chief Conservator of Forests and accord administrative and financial sanction for the amount of Rs.38,22,00,000/- (Rupees Thirty eight crore and twenty two lakh only) for carrying out approved activities in the Annual Plan of Operation of Tamil Nadu for the financial year 2022-2023 from the State Compensatory Afforestation Fund, Tamil Nadu under Section 4 of Compensatory Afforestation Fund Act, 2016, subject to conditions mentioned in the Government of India's letter fifth read above.

- 12. The Accountant General is also requested to transfer the amount from the interest-bearing reserve fund to the newly created Revenue Expenditure Head of Account for draw and disburse the amount for carrying out the works approved in Annual Plan of Operation of Tamil Nadu Compensatory Afforestation Fund Management and Planning Authority for the year 2022-2023.
- 13. The Principal Chief Conservator of Forests is hereby authorized to incur the expenditure sanctioned at para 7 above and he is also requested to follow the accounting procedures for operation of Tamil Nadu Compensatory Afforestation Fund Management and Planning Authority issued in the G.O.(Ms) No.20, Environment, Climate Change and Forests Department, dated 31.01.2022.

- 14. The expenditure sanctioned in para 7 above shall constitute an item of "New Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2022-23. Pending approval of the Legislature, the expenditure shall be initially met by drawl of an advance from the Contingency Fund. Orders regarding this will be issued by the Finance (BG.I) Department separately. The Principal Chief Conservator of Forests, shall apply to the Government in Finance (BG.I) Department in prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. The Principal Chief Conservator of Forests, shall also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2022-23 to Finance (AHDF&FW/ BG-I) Department, without fail.
- 15. The Principal Chief Conservator of Forests is the Estimating, Reconciling and Controlling authority for the new head of account opened at para-8 (6) above. The Pay and Accounts Officer / Treasury Officer concerned are directed to open the above said new Head of Account in their Books.
